The Rocky Mountain-Plains Chapter held its first meeting in Boulder, Colorado, on May 18 and 19. Thirty-three people from eight states in the region attended the meeting. A gratifying amount of enthusiasm was generated, indicating a secure future for MLA's newest chapter.

At Thursday's opening session, Dr. William Kearns of the University of Colorado-Boulder presented an overview of folksong scholarship in the United States and a sampling of tunes from the Ben Gray Lumpkin Collection of Colorado Folklore which has recently been acquired by CU's Music Library. Thursday afternoon, Martin Rubin of Audio Buff, Inc., Athens, Ohio, gave a talk on the record industry which included some useful advice to librarians on ways they can improve communication and service between the record distributor and the library.

The Chapter was officially organized at the Business Meeting late Thursday afternoon. The constitution and by-laws were adopted, dues were set, and the following officers were elected:

The officers subsequently appointed Charlemoud Curtis, University of New Mexico, Program Chairperson, and Peri Switzer, University of Colorado-Auraria Campus, Newsletter Editor.

During Friday's first session, CU's Dr. Storm Bull shared some delightful anecdotes from his long career as a collector of biographical information. His talk also touched on problems of transliteration and travelling overseas. After lunch on Friday, an Open Forum on "Sound Recordings in the Library", with Arne Arneson, moderator, and panelists Leanne Kunkle (University of Colorado-Boulder), Norman Savig (University of Northern Colorado), Pamela Massey, Barbara Gaeddert (University of Kansas), and Martin Rubin, inspired a lively dialog on approaches to cataloging, classification, and circulation. The meeting concluded with an enlightening talk by James Vassar of the United States Copyright Office on the new copyright law as it concerns music librarians.

The next meeting will be held in the Spring of 1979 in Albuquerque, New Mexico.

MOUNTAIN-PLAINS CHAPTER

CONSTITUTION AND BY-LAWS (adopted May 18, 1978)

ARTICLE I: Name and Relationship to the Music Library Association

The name of this organization shall be the Mountain-Plains Chapter of the Music Library Association, herein referred to as the Chapter. The Chapter shall be responsible to, and is a representative agency of, the Music Library Association. The Music Library Association shall herein be referred to as the Association.

ARTICLE II: Purpose

The purpose of the Chapter shall be to encourage communication and cooperation among libraries and individuals who are interested in music and libraries.

ARTICLE III: Membership

Membership in the Chapter shall be open to persons and institutions interested in furthering the purposes of the Chapter. For the Association, the Chapter shall represent the states of Arizona, Colorado, Idaho, Kansas, Montana, Nebraska, Nevada, New Mexico, North Dakota, Oklahoma, South Dakota, Utah, and Wyoming, but shall not be limited to those states. Chapter membership shall not require Association membership. Applications for membership shall be addressed to the Secretary-Treasurer.

ARTICLE IV: Organization

The Chapter Board shall consist of a Chairperson, a Chairperson-Elect, a Secretary-Treasurer, a Member-At-Large, and a Newsletter Editor.

Officers of the Chapter, their functions, terms of office, and the manner of their election or appointment shall be as follows:

1. Chairperson. The Chairperson shall preside at all meetings of the Chapter and the Board. He/she shall be responsible for carrying out the purposes and activities of the Chapter as stated in the Constitution and By-laws. The Chairperson or the Chairperson's designee shall represent the Chapter at all Association meetings. The Chairperson shall serve a two-year term.
2. Vice Chairperson/Chairperson-Elect. The Vice-Chairperson/Chairperson-Elect shall automatically succeed to the office of Chairperson at the end of the two-year term. He/she shall discharge the functions of the Chairperson in case of the latter's disability or absence, or at the latter's request. He/she shall serve a two-year term, and shall be a voting member of the Board. He/she shall be Chair of the Membership Committee and have responsibility for membership development.
3. Secretary-Treasurer. The Secretary-Treasurer shall maintain membership records, collect membership dues, receive all moneys, and deposit them in the name of the Chapter. He/she shall pay all bills and prepare a report to the Chapter. The Secretary-Treasurer shall also prepare minutes of Chapter Meetings, and serve as a voting member of the Board. The Secretary-Treasurer shall serve a two-year term.
4. Member-At-Large. The Member-At-Large shall assist and advise wherever necessary in order to further the purposes and activities of the Chapter. The Member-At-Large shall be a voting member of the Board and serve a two-year term.
5. Newsletter Editor. The Newsletter Editor shall be appointed by the Board, and shall solicit, edit and publish appropriate announcements or articles in the Chapter Newsletter. The Newsletter Editor shall be a voting member of the Board.

6. Program Chairperson. The Program Chairperson shall be appointed by the Board, and shall be responsible for arranging, in cooperation with the officers heretofore designated, the next Annual Meeting from the date of his/her appointment.
7. Elections. All officers except the Program Chairperson shall be required to be members of the Association. The officers shall be elected by a mail ballot not less than thirty days prior to the Annual Meeting. Election shall be by individual ballot and a simple majority of ballots cast shall be requisite for election. Vacancies arising between Annual Meetings shall be filled by the Board.

ARTICLE V: Membership Dues, Voting, and Annual Meetings

1. Annual Dues in an amount to be established by the Board shall be paid by each member on or before January 1. Student membership shall be one-half the amount required of regular members.
2. Voting members of the Chapter shall be all members who have paid dues in full. For the purposes of voting at Annual Meetings, a quorum shall consist of those voting members present. All votes, mail or otherwise, shall be decided by a simple majority. A majority vote of the Board shall break a tie.
3. Meetings. There shall be an Annual Meeting of the Chapter at a time and place fixed by the Board. Special meetings may be called by the Chairperson or the Board, and shall be called upon the request of at least ten percent of the members of the Chapter. Announcements of all meetings shall be at least thirty days in advance.

ARTICLE VI: Standing Committees

1. The Standing Committee of the Chapter shall be the Membership Committee. The Membership Committee shall consist of at least three persons serving two-year terms, chaired and appointed by the Vice-Chairperson/Chairperson-Elect. The Committee shall be responsible for membership development and nominations.
2. As need arises, other committees may be established by the majority of the voting members.

ARTICLE VII: Newsletter

An informational Chapter newsletter shall be published on a regular basis. The Newsletter Editor, in cooperation with the Chapter membership, shall be responsible for soliciting appropriate material and publishing the newsletter.

ARTICLE VIII: Amendments

The Constitution and By-Laws shall be adopted by voting members at an Annual Meeting, and may be amended at any Annual or Special Meeting by a two-thirds majority. Proposed amendments shall be announced at least thirty days in advance of the meeting.

ARTICLE IX: Parliamentary Authority

The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern the Chapter in all cases to which they are applicable and in which they are not inconsistent with this constitution and any special rules of order the Chapter may adopt.

A UNION CATALOG OF REFERENCE HOLDINGS
IN MUSIC LIBRARIES OF THE MOUNTAIN-
PLAINS REGION: PART I, DUCKLES
HOLDINGS

This worksheet is the first step in the proposed Union Catalog of Reference Holdings. Column 1 lists citation numbers from Vincent Duckles' Music Reference and Research Materials: An Annotated Bibliography (3d edition, New York: The Free Press, 1974). Column 2 indicates (by an asterisk) items owned by the University of Colorado at Boulder Libraries (CoU). Column 3 has been left blank so that you may copy this list, and return YOUR checklist of holdings. When a significant number of libraries have responded, the entire union list will be produced in Conventional Title. In the meantime, we hope that this list will serve as an incentive to annotating your Duckles and as an initial step in sharing library resources. We would also hope that you append the list to your working copy of Duckles, and begin using our resources on a cooperative basis.

In order to make these compilations as painless as possible, editions updates since Duckles 3d are not indicated, and multi-volume citations cannot be assumed to be complete in all cases (the asterisk only indicates that at least one volume in a multi-volume set is held). Numbers not included indicate main entries for multi-volume sets analyzed in Duckles (such as Ernst Bücken's Handbuch der Musikwissenschaft, listed as Duckles 381, with separate volumes cited as 382-394).
